NOTES TO THE ACCOUNTS

FOR THE PERIOD 1ST JANUARY TO 31ST DECEMBER 2019

RECEIPTS 1.

Friends of Richmond Green received total payment £13,950 in 2019 from a number of film companies during the year. This included Peter Rabbit, Ted Lasso and Four Weddings Productions. These payments were made as compensation to residents for any disruption caused by the filming. This year Friends of Richmond Green in collaboration with Richmond Council Film office have recently produced a set of guidelines for filming on the Green and surrounding areas.

2. **DONATIONS**

During 2019 there were three donations to the Drinking Fountain Project from Richmond Council Civic Pride Fund and two local donors.

COST OF AGM 3.

These costs relate to the provision of refreshments at the AGM.

RICHMOND HEATHROW PROJECT 4.

This was established at the start of 2008 jointly by Friends of Richmond Green and The Richmond Society, and subsequently joined by the Kew Society, to act as a voice specifically for the residents of Richmond in the campaign against the proposals to expand Heathrow. Since RHC has no funds of its own, it was envisaged that its activities would be paid for by the three founding organisations. The FoRG Committee keeps the expenditure on RHC under close scrutiny at all times.

SURPLUS

The Committee have taken the view that this surplus, which has been generated over more than ten years, should, when appropriate, be used for the general benefit of the residents or for the improvement in the environment of Richmond Green in line with the aims of Friends of Richmond Green. The Committee continually has projects under review. The surplus under 2019 will be used for the Restoration of the Drinking Fountain on the Green.
